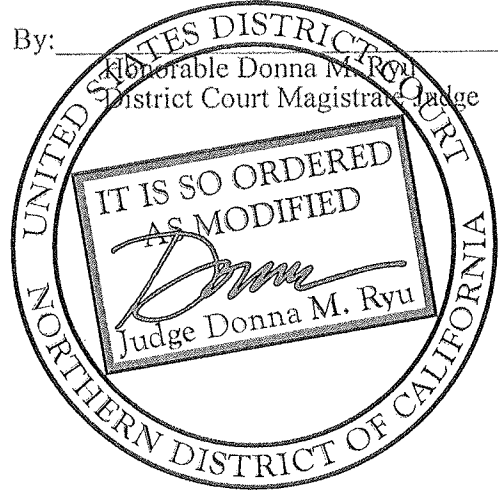
1 said Defendants contacted all other counsel in the case regarding Defendants' request to be excused
