STIPULATION AND ~~[PROPOSED ORDER]~~
 SETTling ATTORNEY'S FEES AND COSTS
 PURSUANT TO THE EQUAL ACCESS TO
 JUSTICE ACT, 28 U.S.C. § 2412(d)

IT IS HEREBY STIPULATED by and between the parties through their undersigned counsel, subject to the approval of the Court, that Plaintiff be awarded attorney fees under the Equal Access to Justice Act (EAJA), 28 U.S.C. § 2412(d), in the amount of FOUR THOUSAND EIGHT HUNDRED FIFTY DOLLARS (\$4,850.00) and costs in the amount of FOUR HUNDRED DOLLARS (\$400.00), the total amount being FIVE THOUSAND TWO HUNDRED FIFTY DOLLARS (\$5,250.00). This amount represents compensation for all legal services rendered and costs advanced on behalf of Plaintiff by counsel in connection with this civil action, in accordance with 28 U.S.C. § 2412(d).

After the Court issues an order for EAJA fees, expenses and costs to Plaintiff, the government will consider the matter of Plaintiff's assignment of EAJA fees and expenses and costs to Plaintiff's attorney. Pursuant to *Astrue v. Ratliff*, 130 S.Ct. 2521 (2010), the ability to honor the assignment will depend on whether the fees, expenses and costs are subject to any offset allowed under the United States

1 Department of the Treasury's Offset Program. After the order for EAJA fees, expenses and costs is
2 entered, the government will determine whether they are subject to any offset.

3 Fees, expenses and costs shall be made payable to Plaintiff, but if the Department of the Treasury
4 determines that Plaintiff does not owe a federal debt, then the government shall cause the payment of
5 fees, expenses and costs to be made directly to Geri N. Kahn, pursuant to the assignment executed by
6 Plaintiff. Any payments made shall be delivered to Plaintiff's counsel at

9 This stipulation constitutes a compromise settlement of Plaintiff's request for EAJA attorney fees,
10 expenses and costs, and does not constitute an admission of liability on the part of Defendant under the
11 EAJA. Payment of the agreed amount shall constitute a complete release from, and bar to, any and all
12 claims that Plaintiff and/or Plaintiff's counsel may have relating to EAJA attorney fees and expenses and
13 costs in connection with this action.

14 This award is without prejudice to the rights of Plaintiff's counsel to seek Social Security Act
15 attorney fees under 42 U.S.C. § 406, subject to the provisions of the EAJA.
