1 Plaintiffs IXI Mobile (R&D) Ltd. and IXI IP, LLC (collectively "IXI" or "Plaintiffs") and  
2 Defendants Samsung Electronics Co., Ltd. and Samsung Electronics America, Inc. ("Samsung") submit  
3 this Joint Stipulation of Dismissal.

- 5 1. WHEREAS: IXI has granted Samsung certain covenants not to sue related to certain claims of  
6 the Asserted Patents (U.S. Patent Nos. 7,016,648; 7,039,033; 7,295,532; and 7,426,398);

8 2. WHEREAS: The Parties agree to dismiss this action without prejudice; and

10 3. WHEREAS: Defendants have agreed that it will not use the aforementioned covenant not to  
11 sue or this Stipulation and Order as a basis for any claim or defense against IXI's enforcement  
12 of the claims of U.S. Patent No. 7,039,033 that issued as a result of IXI's reexamination or of  
13 claims that may issue as a result of the previously completed or currently pending  
14 reexaminations of U.S. Patent Nos. 7,039,033 or 7,295,532 brought by Apple Inc. and  
15 Samsung;

16 **IT IS ORDERED** that Civil Action NO. 4-15-cv-03752-HSG is hereby **DISMISSED WITHOUT**  
17 **PREJUDICE**. **IT IS FURTHER ORDERED** that Defendants will not use the aforementioned covenant  
18 not to sue or this Stipulation and Order as a basis for any claim or defense against IXI's enforcement of  
19 the claims of U.S. Patent No. 7,039,033 that issued as a result of IXI's reexamination or of claims that  
20 may issue as a result of the previously completed or currently pending reexaminations of U.S. Patent  
21 Nos. 7,039,033 or 7,295,532 brought by Apple Inc. and Samsung.
