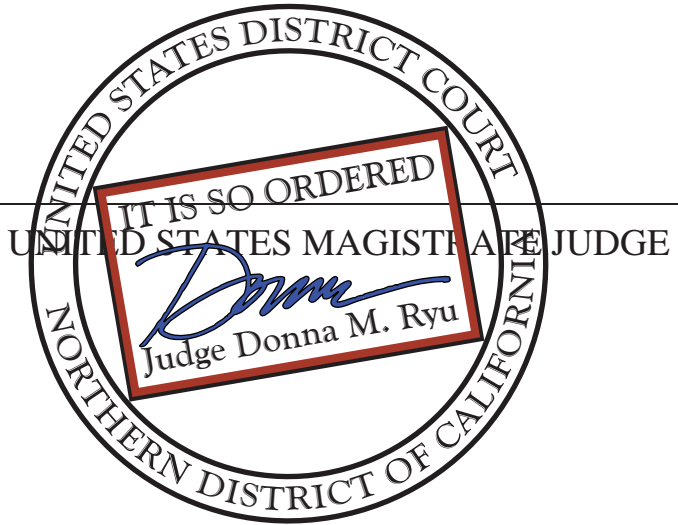
The above REQUEST AND PROPOSED ORDER is approved and the Case Management Conference and Defendant TD Bank USA, N.A.'s ("TD Bank")


