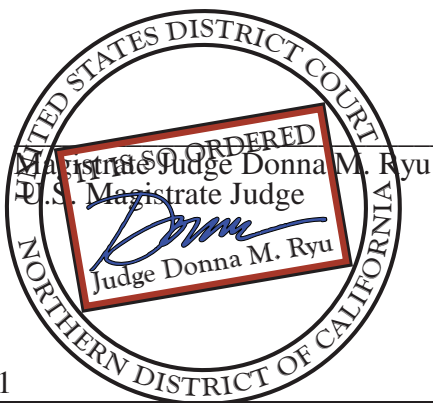
**TO THE COURT, THE DEFENDANT AND ALL OTHER INTERESTED PARTIES:**
