Pursuant to Fed. R. Civ. P. 41, Civ. L.R. 7-12, and the agreement of the parties,
 Plaintiff Myoung Ho Lee (“**Lee**”) on the one hand, and Defendant Tatoumik Limited
 (“**Tatoumik**”) on the other hand, by and through their respective counsel of record, hereby
 stipulate and agree as follows:

1. In this action, via its Complaint Lee asserted claims of infringement of
 U.S. Copyright Registration No. VA0001968065, violation of the Lanham Act, and related
 claims against Tatoumik.

1 2. Tatoumik filed an Answer to the Complaint, denying all material
2 allegations asserted therein and denying liability.

3 3. Lee and Tatoumik have now reached an agreement to settle their
4 differences relating to the above-captioned action.

5 4. All claims Lee asserted against Tatoumik, including those asserted in its
6 Complaint in the above-captioned action are hereby dismissed with prejudice.
