On October 10, 2016, Defendants U.S. Bank National Association, as successor trustee to Bank of America, National Association successor by merger to LaSalle Bank NA as trustee for WaMu Mortgage Pass-Through Certificates Series 2007-HY6 Trust (“U.S. Bank Trustee”) (incorrectly sued herein as Trustee US Bank, NA as successor to Bank of America, NA, successor to LaSalle Bank NA as Trustee on behalf of the Certificate Holders of WAMU-RMBS Pass-Thru Series 2007-HY6 under the Pooling And Servicing Agreement dated May 1, 2007) and Select Portfolio Servicing, Inc. (“SPS”) (collectively with U.S. Bank Trustee, “Defendants”) filed their motion for attorney fees against Plaintiff Mary Ng (“Plaintiff”), setting a hearing thereon for November 17, 2016, at 11:00 a.m.

2. On October 18, 2016, Defendants filed their motion to expunge the notice of pendency of action, setting a hearing thereon for December 1, 2016, at 11:00 a.m.
