2	Pursuant to the stipulation submitted to this Court by plaintiff Nora Salamanca ("Plaintiff")		
3	and defendant Sprint/United Management Company ("Defendant" or "Sprint") (collectively, the		
4	"Parties") on June 6, 2016, the Court, finding good cause therefor, hereby ORDERS as follows:		
5	1. All proceedings in this case (including all obligations to respond to discovery, to
