Petitioner, a state prisoner, filed a petition for a writ of habeas corpus under 28 U.S.C. § 2254. The original petition sought an order compelling a state court to conduct a hearing regarding petitioner's state habeas petition challenging a disciplinary hearing resulting in the forfeiture of time credits. Petitioner has filed an amended petition solely challenging the disciplinary hearing.

Venue for a habeas action is proper in either the district of confinement or the
district of conviction, 28 U.S.C. § 2241(d). If the petition is directed to the manner in
which a sentence is being executed, e.g., if it involves parole or time credits claims, the
district of confinement is the preferable forum. See Habeas L.R. 2254-3(b)(2); *Dunne v. Henman*, 875 F.2d 244, 249 (9th Cir. 1989). The petition indicates that petitioner is
confined at the California State Prison-Solano, which lies within the venue of the Eastern
District of California. See 28 U.S.C. § 84(b).¹
