**JUDGMENT ON VERDICT**

29 This action came on for trial on March 12, 2018, in Courtroom 1 of the United States  
 30 District Court, Northern District of California, Oakland Division, Honorable Yvonne Gonzalez  
 31 Rogers, presiding. The Plaintiff in this case, No. CV 16-00050-YGR, Jamal Rashid Trulove, was


1 represented by Nick Brustin, Anna Benvenuti Hoffmann, Meghna Philip, Alex Reisman, and  
2 Kate Chatfield. Defendants Maureen D'Amico, Michael Johnson, John Evans, and Robert  
3 McMillan, were represented by the San Francisco City Attorney's office, through Deputy City  
4 Attorneys Margaret Baumgartner, Kelly Collins, and Renee Rosenblit.

6 Witnesses were sworn and testified. After hearing the evidence, the jury was instructed  
7 by the Court and the case was submitted to the jury. Eight sworn jurors deliberated. The issues  
8 having been duly tried and the jury having duly rendered its verdict for plaintiff and against  
9 Defendants Michael Johnson and Maureen D'Amico only ([Dkt 523]:

10 IT IS ORDERED that Plaintiff Jamal Rashid Trulove shall recover the sum of  
11 \$10,000,000.00 from Maureen D'Amico and Michael Johnson, plus post-judgment interest,  
12 costs, and attorney's fees as provided by law. Plaintiff shall file any application for costs or  
13 attorneys' fees by May 14, 2018. Defendants shall respond by June 1, 2018, and Plaintiff shall  
14 reply by June 8, 2018.

15  
16 IT IS ALSO ORDERED that Plaintiff shall take nothing from Defendants John Evans  
17 and Robert McMillan. Defendants Evans and McMillan contend that they are entitled to costs,  
18 and shall file an application for costs per statutory deadlines.
