- 4 1. The close of fact discovery is extended from August 3, 2018 through and
5 including September 14, 2018.
- 6 2. The deadline to disclose expert witnesses is extended from August 31, 2018
7 through and including October 12, 2018.
- 8 3. The deadline to disclose rebuttal expert witnesses is extended from October 19,
9 2018 through and including November 21, 2018.
- 10 4. The close of expert discovery is extended from November 2, 2018 through and
11 including December 21, 2018.
- 12 5. The deadline to file dispositive motions is extended from December 7, 2018
13 through and including January 4, 2019.
- 14 6. The deadline to oppose dispositive motions is extended from January 4, 2019
15 through and including January 23, 2019.
- 16 7. The deadline to file replies in support of dispositive motions is extended from
17 January 25, 2019 through and including January 31, 2019.
- 18 8. The deadline to file *Daubert* motions is extended from February 1, 2019 through

- 20 9. The deadline to file oppositions to *Daubert* motions is extended from February
21 15, 2019 through and including March 1, 2019.
- 22 10. The deadline to file replies in support of *Daubert* motions is extended from March
23 1, 2019 through and including March 14, 2019.


