21 **PLEASE TAKE NOTICE** that, pursuant to Federal Rule of Civil Procedure Section
 22 40(a)(1)(A)(ii), Plaintiff Halcyon Syndicate Ltd. LLC (“Plaintiff”) and Defendant Appellation
 23 Wine Marketing, Ltd. (“Defendant”) hereby stipulate as follows:
