Based upon Philz's understanding and agreement that it has been satisfactorily dismissed from the action with prejudice by the Court, Plaintiff has agreed to remove Philz as a defendant from her action. Plaintiff further stipulates that in her proposed first amended complaint, the claims for equitable relief and damages she pursues against 1600 Shattuck are only those that were not resolved by the settlement agreement between Plaintiff and Philz.
