1 Pursuant to the Court's Pretrial Instructions in Civil Cases at Section 2, trial counsel shall meet
2 and confer in advance of the Pretrial Conference. The compliance hearing on Friday, August 17,
3 2018 at 9:01 a.m. is intended to confirm that counsel have reviewed the Court's Pretrial Setting
4 Instructions and are in compliance therewith. The compliance hearing shall be held in the Federal
5 Courthouse, 1301 Clay Street, Oakland, California, in Courtroom 1. Five (5) business days prior
6 to the date of the compliance hearing, the parties shall file a one-page JOINT STATEMENT
7 confirming they have complied with this requirement or explaining their failure to comply. If
8 compliance is complete, the parties need not appear and the compliance hearing will be taken off
9 calendar. Telephonic appearances will be allowed if the parties have submitted a joint statement
10 in a timely fashion. Failure to do so may result in sanctions.

11 A compliance hearing regarding date of mediation with private mediator or a request for
12 the Court to refer the case to ADR for an ADR process shall be held on **Friday, October 6, 2017**
13 on the Court's 9:01a.m. calendar, in the Federal Courthouse, 1301 Clay Street, Oakland,
14 California, in courtroom 1. By September 29, 2017, the parties shall file either the JOINT Notice
15 or a one-page JOINT STATEMENT setting forth an explanation for their failure to comply. If
16 compliance is complete, the parties need not appear and the compliance hearing will be taken off
17 calendar. Telephonic appearances will be allowed if the parties have submitted a joint statement
18 in a timely fashion.

19 The parties must comply with both the Court's Standing Order in Civil Cases and Standing
20 Order for Pretrial Instructions in Civil Cases for additional deadlines and procedures. All
