 ORDER TO AMEND SCHEDULING ORDER

16 Plaintiff Adela E. Gomez and defendant Commissioner of Social Security, through their  
 17 counsels of record, jointly request to amend the Court’s Scheduling Order in this action as follows.

18 IT IS STIPULATED, that the untimely filing of plaintiff’s Motion for Summary Judgment
