16 This case will be tried to a jury.

17 Counsel may not modify these dates without leave of court. The parties shall comply with
18 the Court's standing orders, which are available at cand.uscourts.gov/jstorders.

19 The parties must take all necessary steps to conduct discovery, compel discovery, hire
20 counsel, retain experts, and manage their calendars so that they can complete discovery in a timely
21 manner and appear at trial on the noticed and scheduled dates. All counsel must arrange their
22 calendars to accommodate these dates, or arrange to substitute or associate in counsel who can.

23 Trial dates set by this Court should be regarded as firm. Requests for continuance are
24 disfavored. The Court will not consider any event subsequently scheduled by a party, party
25 controlled witness, expert or attorney that conflicts with the above trial dates as good cause to grant
26 a continuance. The Court will not consider the pendency of settlement discussions as good cause
27 to grant a continuance.
