1 WHEREAS, on June 6, 2018, the Court approved the proposed scheduling order of the
2 parties and entered a scheduling order (“Scheduling Order”) setting a briefing schedule on
3 Defendants anticipated Motion to Dismiss [Doc. 68].

4 WHEREAS, pursuant to the Scheduling Order, Plaintiffs filed their Consolidated
5 Complaint for Violation of Securities Laws (“Complaint”) on July 20, 2018 [Doc. 83]. The
6 Complaint, excluding exhibits, was 130 pages long and contained 437 paragraphs of allegations.

7 *Id.*

8 WHEREAS, on September 10, 2018 counsel for Defendants contacted counsel for
9 Plaintiffs requesting Plaintiffs stipulate to oversized briefs given the size and nature of Plaintiffs’
10 Complaint. Pursuant to those discussions, the parties agreed that Defendants would file one
11 combined brief on behalf of all Defendants and be permitted 40 pages for their brief in support of
12 the anticipated Motion to Dismiss and that Plaintiffs would be similarly permitted 40 pages for
13 their brief in response.

14 IT IS HEREBY STIPULATED AND AGREED, by and among the undersigned, that:

- 15 1. The page limit imposed by Local Rule 7-4(b) with respect to Defendants’ anticipated
16 Motion to Dismiss, which will be one combined brief for all Defendants, is extended
17 to forty (40) pages.
- 18 2. The page limit imposed by Local Rule 7-4(b) with respect to Plaintiffs’ response to
19 Defendants’ anticipated Motion to Dismiss is extended to forty (40) pages.


