**JOINT STIPULATION AND
 [PROPOSED] ORDER TO EXTEND
 ADR DEADLINE**

Hon. Haywood S. Gilliam, Jr.

1 Pursuant to Civil Local Rules 6-2 and 7-12, Plaintiff Ipsilium LLC (“Ipsilium”) and
2 Defendant Cisco Systems, Inc. (“Cisco”) (collectively, “the Parties”) hereby jointly stipulate and
3 agree as follows, subject to the approval of the Court, to extend the deadline to complete mediation:

4 WHEREAS, under the June 29, 2018 Joint Stipulation and Order to Extend Deadlines (Dkt.
5 No. 46) the deadline for the parties to complete mediation was extended one week, from August 31,
6 2018 to the current deadline of September 7, 2018; and

7 WHEREAS, Cisco served its Response Damages Contentions on August 22, 2018, the
8 parties recently made their claim construction disclosures under Pat. L.R. 4-3, and they will file a
9 Joint Claim Construction Statement on August 30, 2018; and

10 WHEREAS, the parties and the court-appointed mediator, Vicki Veenker, have scheduling
11 conflicts between August 30 and September 7, 2018; and

12 WHEREAS, the parties believe that the mediation process would be more effective if they
13 have additional time to consider each other’s claim construction and damages positions; and

14 WHEREAS, the parties have discussed the requested extension with Ms. Veenker, who
15 supports this stipulation; and

16 WHEREAS, the parties and Ms. Veenker have agreed to hold a mediation session on October
17 10, 2018;

18 NOW, THEREFORE, the parties hereby stipulate and request the Court to Order that the
19 deadline for completion of mediation be extended from September 7, 2018 to **October 12, 2018**. No
20 other deadlines will be affected by this change.
