5 The parties, by and through their attorneys, have met and conferred regarding Plaintiff  
6 Felipe Hernandez's ("Plaintiff") complaint and this Court's order extending date to file  
7 responsive pleadings and continuing case management conference and related dates. On  
8 March 30, 2018, the Court ordered Plaintiff to file an amended complaint by April 17, 2018.

22 responsive pleadings.
