3 On March 5, 2016, Plaintiffs served the Summons and Complaint, in the instant action, on the CT
4 Corporation System, on behalf of Defendants CLARENDON NATIONAL INSURANCE COMPANY
5 and Clarendon America. CLARENDON NATIONAL INSURANCE COMPANY represents it is the
6 successor in interest by way of merger with Clarendon America, and represents that Clarendon America
7 merged into CLARENDON NATIONAL INSURANCE COMPANY in 2015. In reliance on
8 CLARENDON NATIONAL INSURANCE COMPANY’s representation, Plaintiffs have agreed to
9 dismiss Clarendon America without prejudice.
