1 **INTEREST OF AMICI**

2 *Amici*, the National Immigration Law Center (“NILC”), Asian Americans Advancing Justice-  
3 AAJC (“Advancing Justice-AAJC”), Asian Americans Advancing Justice-Los Angeles  
4 (“Advancing Justice-Los Angeles”), the Asian American Legal Defense and Education Fund  
5 (“AALDEF”), Black Alliance for Just Immigration (“BAJI”), and LatinoJustice PRLDEF are all  
6 nonprofit organizations dedicated to advancing and defending the constitutional rights of diverse  
7 communities of color, immigrant communities, and their families. *Amici’s* interest in the outcome  
8 of this case arises out of *amici’s* efforts to defend against the racial animus and xenophobic nature  
9 of the Executive’s immigration policies as well as their concern for the harms to immigrant  
10 communities and communities of color when the Executive takes unilateral action to exclude  
11 immigrants.

12  
13 **SUMMARY OF ARGUMENT**

14 The instant case involves the Executive’s claim that it has the power to build that which  
15 Congress has expressly refused. On February 15, 2019, the Trump Administration announced that  
16 the President was taking Executive Action to redirect an additional \$6.7 billion in funding beyond  
17 what was appropriated by Congress toward construction of a “border wall”, and declared a national  
18 emergency under the National Emergencies Act.<sup>1</sup> The Emergency Declaration claimed that “the  
19 problem of large-scale unlawful migration through the southern border is long-standing,” and that  
20 “the southern border is a major entry point for criminals, gang members, and illicit narcotics” and  
21 that “despite executive branch’s exercise of existing statutory authorities, the situation has  
22 worsened in certain respects in recent years.”<sup>2</sup>

1 While, within this litigation, the Executive is now also asserting non-emergency powers, those  
2 allegations are nonetheless a purported basis for the Executive’s unilateral actions. The  
3 Executive’s claims of necessity for a “wall” along the southern border with Mexico are grounded  
4 in discriminatory animus and steeped in racialized and xenophobic tropes. The Executive’s  
5 desired result from its usurpation of Congressional authority—the construction of a border wall—  
6 has previously been attempted. Those attempts failed at their goal of decreased or deterred  
7 migration and instead resulted in migrant deaths and serious social, psychological, and  
8 environmental harms to border communities. This history reveals that the current Executive’s  
9 unilateral efforts to install physical barriers along the U.S.-Mexico border will likely result in many  
10 of the same harms, except at a much larger scale—and with a much higher multiplier in terms of  
11 the costs, risks, depth, and breadth of harm to the public. Because Defendants’ assertions of a  
12 proper basis for their actions is undermined by abundant evidence of improper motive, and because  
13 a preliminary injunction is in the public interest, amici respectfully request this Court grant  
14 Plaintiffs’ motion.

## 15 ARGUMENT

### 16 I. BORDER WALLS PROVED INEFFECTIVE AT DETERRING IMMIGRATION 17 AND CREATED A HUMANITARIAN CRISIS

18 The notion of “walling off” the southern border between the United States and Mexico is  
19 relatively new.<sup>3</sup> Indeed, the most significant instance of border wall construction designed to deter  
20 entry along the United States-Mexico border occurred in the 1990s.

1           **A. Initial Executive Actions to Erect a Border Wall**

2           First, in 1990, the U.S. Border Patrol (“CBP”) erected the initial formal physical barrier along  
3 the U.S.-Mexico border, also known as the “primary fence”.<sup>4</sup> Second, in 1993, Silvestre Reyes,  
4 Border Patrol Chief of the El Paso Sector at the time,<sup>5</sup> “unilaterally launched Operation Blockade  
5 (renamed ‘Hold-the-Line’ as the former proved to be quite offensive to the Mexican government)  
6 in the El Paso Border region,” sending 400 agents and their vehicles in a high-profile “show of  
7 force” along a 20-mile section of the boundary that divides El Paso, Texas in the United States  
8 from Ciudad Juarez in Mexico.<sup>6</sup>

9           The following year, perhaps the most notable 1990s-era barrier erection began, “Operation  
10 Gatekeeper.” There, the federal Executive sought to construct a “wall” to advance a “Prevention  
11 through Deterrence” policy, by creating multiple physical barriers, walls, and secondary fencing  
12 to “increase the [U.S. Border Patrol’s] ability to discourage a significant number of illegal border  
13 crossers, to detect intruders early[,] delay them as long as possible, and to channel a reduced  
14 number of illegal border crossers to geographic locations where the [Border Patrol] was better  
15 prepared to deal with them.”<sup>7</sup> Under the auspices of the Immigration and Naturalization Service  
16 (“INS”), Operation Gatekeeper resulted in construction of multiple layers of secondary fencing  
17 around the primary fence, to create a “wall” along a 14-mile stretch of the California-Mexico  
18 border from the Pacific Ocean at Imperial Beach eastward to the Otay Mountains.<sup>8</sup> The Executive  
19 later expanded the fence-building project to Nogales, Yuma, and Tucson, Arizona and El Paso,

1 Texas.<sup>9</sup> “The vision for Operation Gatekeeper was also embodied in the [INS] San Diego Sector’s  
2 own strategic planning document published in April 1994.”<sup>10</sup> While “the 14-mile section had  
3 been the focus of some resources before Gatekeeper”, as “[s]teel fencing and bright lighting was  
4 already in place in sections of this corridor....Phase I of Gatekeeper, which would require up to  
5 two years to complete, further increased staffing and resources along the 14-mile stretch.”<sup>11</sup>

6 Beyond the 14 miles of primary fencing, the INS built two “back-up” 15-foot tall fences, the  
7 first constructed of concrete pillars and rimmed with barbed wire. Twelve of the 14 miles of this  
8 section were dotted with stadium lights, and some of the fencing was constructed on the Otay  
9 Mountains, as well as around various East San Diego County communities along the border.<sup>12</sup>

10 In 1995, Operation Safeguard followed in Nogales, Arizona, resulting in “17 miles of  
11 fencing—six in the Yuma sector and nine in the Tucson sector—erected exclusively in towns and  
12 cities, with three miles of lighting; along with Operation Rio Grande (August 1997) in McAllen  
13 and Laredo, Texas, as well as seven miles of fencing in the El Paso/Ciudad Juarez area—two miles  
14 of primary and five miles of secondary fencing.<sup>13</sup> As a result of these actions, the INS “erected  
15 73 miles of fencing on the 2,000 mile border, 72 percent of it along the 66 mile San Diego sector.”<sup>14</sup>

16 **B. The 1990s “Wall” Effort Caused a Humanitarian Crisis, Instead of Achieving the**  
17 **Purported Goals of “Wall” Construction**

18 Rather than preventing migration, these enforcement efforts and barriers simply  
19 geographically redistributed migrant border crossings. Between 1994 and 2000, for example,

1 apprehensions in San Diego declined 66 percent but grew 351 percent in the Tucson and Yuma  
2 sectors in Arizona as migrants were pushed east.<sup>15</sup> These new crossing points were in more remote  
3 areas: subsequently, migration journeys became more difficult and dangerous. Migration scholar  
4 Wayne Cornelius argues that the increased costs and risks of these journeys “should not be treated  
5 as ‘unintended’ consequences, since they were an integral part of the INS’s ‘prevention through  
6 deterrence’ strategy from its inception.”<sup>16</sup> By implementing prevention through deterrence  
7 strategies like Operation Gatekeeper, the “evidence suggests that the policy and practice instituted  
8 under Operation Gatekeeper explicitly relied on the assumption that migrants would either be  
9 discouraged from entering the country or die trying.”<sup>17</sup>

10 As a result of geographic shifts in crossing and more hazardous crossing conditions,  
11 “prevention through deterrence” has been associated with changes in the locations of migrant  
12 deaths, changes in causes of deaths, and overall increases in the incidence of deaths.<sup>18</sup> By 1997,  
13 researchers documented a sharp increase in deaths in Imperial County, California, which runs East  
14 of San Diego to the Arizona border.<sup>19</sup> Later, between 1996 and 2000, deaths increased in Arizona  
15 by 1,186 percent and in Texas by 1,181 percent.<sup>20</sup> In total, deaths among those attempting to cross  
16 the Southwest border without authorization during this period increased by 474 percent.<sup>21</sup>  
17 Migrants increasingly perished from environmental causes—hypothermia, dehydration, and  
18

1 sunstroke—and by drowning.<sup>22</sup> Between 1993 and 1997, researchers estimated conservatively that  
2 there were more than 1,600 deaths on the northern side of the U.S.-Mexico border.<sup>23</sup> By 2004,  
3 there were 2,952 documented deaths associated with unauthorized attempts to cross the border.<sup>24</sup>

4 Increased deaths during the 1990s cannot be explained solely by increased migration flows, as  
5 “per-year increases in mortality [we]re much larger than the increases in Border Patrol  
6 apprehensions.”<sup>25</sup> Between Fiscal Years 1998 and 2003, the probability of a migrant dying versus  
7 being apprehended doubled.<sup>26</sup> Overall, empirical studies demonstrate that Operation Gatekeeper  
8 and the initiation of the border fence project, in practice, turned out be “costly and ineffectual in  
9 accomplishing its stated goals” and that it has led to “significant death without any deterrence.”<sup>27</sup>

10 Migrants who do not die experience physical suffering and violence on journeys through  
11 hazardous terrain.<sup>28</sup> A survey of returned migrants in Mexico in 1999-2000 found that 70 percent  
12 experienced a physical risk during their crossing attempt, including more than a third who lacked  
13 water or food.<sup>29</sup> This pattern persists. A 2013 study found that almost forty percent of the  
14 individuals who attempted to cross the border ran out of water in the desert and nearly a third ran

1 out of food.<sup>30</sup> In addition to the physical hazards of the natural environment, migrants are subject  
2 to abuse, abandonment, and violence on journeys across the southern border. Riskier crossings  
3 have given rise to a “migration industry”<sup>31</sup> of coyotes and human smugglers.<sup>32</sup> Migrants  
4 increasingly relied on coyotes to complete crossings and the costs of these guides quadrupled  
5 between 1995 and 2004.<sup>33</sup> Smuggling rings have made migration a “more profitable industry for  
6 organized crime”<sup>34</sup> and drug trafficking.<sup>35</sup> Women are especially at risk: one study that  
7 approximately 12 percent of people who crossed “witnessed some form of violence against women  
8 during the crossing experience[, including] rape, beatings, and even disappearances.”<sup>36</sup>

9 There is good reason to believe that the harms flowing from the radically expanded border  
10 fencing that the Trump Administration is attempting will be similarly, if not more, catastrophic to  
11 those taken by the Executive in the 1990s. Border Patrol statistics from 2006 (the year the Secure  
12 Fence Act was passed, post-Operation Gatekeeper, together with related legislation)<sup>37</sup> demonstrate

1 the correlation between increased fencing and migrant deaths. In fact, since 2006, the number of  
2 deaths per 100,000 migrants almost doubled.<sup>38</sup>

## 3 **II. CONSTRUCTION OF PHYSICAL BARRIERS AT THE BORDER CAUSED** 4 **ECONOMIC, SOCIAL AND ENVIRONMENTAL HARMS**

5 Border communities have suffered serious harms from physical border walls. Border  
6 communities share integrated economies and cultures which are interrupted by “unnatural” barriers  
7 like fences and walls.<sup>39</sup> These barriers have been contested by the residents of those communities:  
8 “religious leaders, community leaders, elected officials, local law enforcement officers, and even  
9 Border Patrol agents.”<sup>40</sup> In the community of Ambos Nogales, which spans Nogales, Sonora and  
10 Nogales, Arizona, the erection of a steel fence in 1996 divided a transnational community.  
11 Although a chain-link fence marked the international border for decades before, this new, intensely  
12 surveilled barrier “blocked lines of sight between the communities and dominated the visual  
13 landscape. It disrupted the sense of community along the border far more seriously than the chain-  
14 link fence.”<sup>41</sup> The Department of Homeland Security replaced this fence with a higher, bollard-  
15 style wall in 2011. These barriers have harmed the local, interconnected economies and prevented  
16 the cooperation of both cities’ fire departments.<sup>42</sup> The barriers, including a five foot tall wall with  
17 metal gates, blocked an underground storm drain during flash flooding in Ambos Nogales in 2008,  
18

1 “where water rose above the tops of the doorframes of shops on the Mexican side of the wall, but  
2 only ankle deep on the U.S. side...[t]ragically, two people drowned in the deep stormwaters, 575  
3 Mexican homes and businesses, and 45 cars were damaged at an estimated cost of \$8 million.<sup>43</sup>  
4 Border fencing, wall construction, and their ensuing risks also separated binational families who  
5 lacked economic resources to secure tourist visas to visit relatives living in the United States,<sup>44</sup>  
6 and drove down wages directly for immigrants seeking agricultural employment in the United  
7 States.<sup>45</sup> It further encroached on public spaces, such as Friendship Park near the Pacific Ocean,  
8 between California and Baja California, which previously enabled binational families to enjoy a  
9 day at the beach together.<sup>46</sup>

11 It also endangered protected cross-border lands and transnational habitats for Thorne’s  
12 Hairstreak butterflies in the Otay Mountain Wilderness Area, birds and fish in the Tijuana Estuary,  
13 endangered Sonoran Pronghorns that roamed the Organ Pipe National Monument, Cabeza Prieta  
14 and Kofa National Wildlife Refuges, as well as the El Pinacate y Gran Desierto de Altar Biosphere  
15 Reserve; endangered rare insects, birds, and fish in the San Pedro Riparian National Conservation  
16 Area, jaguars that roamed the Peloncillo Mountains between Sonora, Arizona, and New Mexico,  
17 ocelots and jaguarundi in the Lower Rio Grande Valley, and the nearly-extinct Mexican Wolf  
18 population that roamed between Chihuahua and Ciudad Juarez in Mexico and Arizona, New  
19 Mexico, and Texas in the U.S., among others.<sup>47</sup>

1 In perpetuating social, cultural, and economic divisions, as well as environmental harms,  
2 communities at the border disproportionately bear the costs of immigration enforcement relative  
3 to communities in the interior United States.<sup>48</sup>

4 Cultural traditions associated with the Tohono O’odham’s sacred land span the border,  
5 including annual pilgrimages to sites located on both sides. The redistribution of migrants due to  
6 border walls, additionally, has meant greater traffic from smugglers and border crossers on their  
7 land, located in remote areas of Arizona. Therefore, Tohono O’odham lands have become an  
8 unwitting site for many migrant deaths. Vehicle barriers that the CBP erected in response to this  
9 traffic have led to further environmental degradation.<sup>49</sup>

10 **III. PRESIDENT TRUMP’S RHETORIC IN SUPPORT OF ADDITIONAL WALL**  
11 **CONSTRUCTION IS THE LATEST EXECUTIVE ACTION IN A**  
12 **RACIALLY DISCRIMINATORY IMMIGRATION POLICY.**

13 President’s Trump’s call to build a “wall” and his claim of an immigration crisis at the southern  
14 border are enveloped in xenophobia and racism. Formally announcing his candidacy for President  
15 in June 2015, President Trump claimed that a border wall is necessary to stop a tide of illegal  
16 immigration, claiming that “It’s coming from more than Mexico. It’s coming from all over South  
17 and Latin America, and it’s coming probably— probably— from the Middle East . . . . And it’s  
18 got to stop and it’s got to stop fast.”<sup>50</sup> In that same speech announcing his campaign, the President  
19 infamously declared that:

20 When Mexico sends its people, they’re not sending their best . . . . They’re sending  
21 you people that have lots of problems and they’re bringing those problems with us. They’re  
22 bringing drugs. They’re bringing crime. They’re rapists. And some, I assume, are good  
23 people.<sup>51</sup>

1 He proposed, in that same speech, after engaging in this openly racialized and xenophobic  
2 rhetoric, that to address these “problems,” he would “build a great, great wall on our southern  
3 border . . . .”<sup>52</sup> He later reaffirmed these remarks as “100 percent correct.”<sup>53</sup>

4 Since taking office, he has continued making misleading and baseless claims that the border  
5 wall he planned to build would help prevent terrorism, criminal activity, and drug trafficking<sup>54</sup>,  
6 despite the fact that the State Department found no credible evidence of a terrorist threat coming  
7 through Mexico<sup>55</sup> and Vice President Pence himself acknowledging that drugs enter “primarily at  
8 points of entry.”<sup>56</sup>

9 President Trump’s faulty justifications rely not only on misrepresentations, but also  
10 xenophobic and racist tropes. President Trump has continued to tweet anti-Mexican statements in

1 relation to the “wall,”<sup>57</sup> and has described immigrants at the southern border as “animals”<sup>58</sup> and  
2 described their entry as an “infestation.”<sup>59</sup>

3 More recently, he has referred to asylum seekers on the southern border as “people who look  
4 like they should be fighting in the UFC [Ultimate Fighting Championship.]”<sup>60</sup> President Trump’s  
5 narrative regarding the purported need for a wall on the southern border is part of a larger  
6 consistent pattern and policy approach that, at its core, is focused on demonizing and targeting  
7 immigrants of color, and which includes reported statements by President Trump claiming that  
8 people entering the United States from Haiti “all have AIDS” and lamenting that Nigerians would  
9 never “go back to their huts[.]”<sup>61</sup> President Trump has also been reported, in reference to African  
10 nations, to state that, Temporary Protected Status means the United States is “having all these  
11 people from shithole countries come here.”<sup>62</sup> He has also unabashedly used his social media  
12 platform to share, endorse and “retweet” false white nationalist claims against people of color  
13 visiting or immigrating to the U.S.<sup>63</sup>

1 These racialized appeals have been intertwined with a steady stream of exclusionary executive  
2 actions that disproportionately impact immigrant communities and United States citizens of color  
3 alike. These include:

4 **Reducing Lawful Entry into the United States:** The Administration sought to ban  
5 individuals traveling into the United States from several Muslim-majority countries.<sup>64</sup> Thereafter,  
6 the Administration has twice sought to slash refugee admissions, cutting the number from 84,995  
7 to 45,000 in 2017<sup>65</sup> and reducing that number to 30,000 in 2019.<sup>66</sup> The Administration seeks to  
8 preclude asylum claims from individuals fleeing gang violence or domestic violence.<sup>67</sup>  
9 Additionally, the Administration has proposed a new regulation that would depart from 100 years  
10 of precedent to deny admission to individuals who it deems might become “public charges”.<sup>68</sup>

11 **Limiting Access to Status:** The Administration has attempted to remove Temporary  
12 Protected Status from individuals from Haiti, Sudan, Nicaragua, El Salvador, Nepal, and  
13

1 Honduras.<sup>69</sup> Moreover, the Administration has attempted to terminate two of the prior  
2 Administration’s deferred action policies.<sup>70</sup> Notwithstanding the Fourteenth Amendment, the  
3 President has also stated his intent to eliminate birthright citizenship.<sup>71</sup>

4 **Attempts to coerce state involvement in federal immigration policy:** The  
5 Administration has sought to preclude so-called “sanctuary cities” from receiving various  
6 government criminal justice grants.<sup>72</sup> Multiple district and circuit courts have rejected those efforts  
7 as exceeding statutory and/or constitutional authority.<sup>73</sup> Recently, the Administration threatened  
8 to release people detained in immigration custody in an apparent belief that such an act would  
9 punish those jurisdictions.<sup>74</sup>

10 In lawsuits challenging these actions, courts have declined to “bury [their] head[s] in the sand  
11 when faced with overt expressions of prejudice.”<sup>75</sup> Instead, they have routinely held that plaintiffs  
12 sufficiently alleged unconstitutional motives based, in part, on the President’s words and  
13 statements.<sup>76</sup> For example, considering the President’s anti-Latino/a statements in the context of

1 ending Temporary Protected Status for El Salvadoran nationals, the District of Maryland explained  
2 that: “One could hardly find more direct evidence of discriminatory intent towards Latino  
3 immigrants,” noting in particular how the President “has broadly painted Latino immigrants as  
4 drug-users, criminals, and rapists.”<sup>77</sup> Often, the Government has not “defend[ed] the President’s  
5 comments but instead argue[d] that the court should simply ignore them.”<sup>78</sup> Even where courts  
6 have ruled in the Administration’s favor on discrimination claims, they have done so in ways that  
7 did not question whether the President’s statements depicted his personal animus.<sup>79</sup> Here, the  
8 record is equally stark, and the Court should not turn a blind eye to the impermissible motives  
9 driving the administration’s actions challenged in the litigation in the instant case.

### 10 CONCLUSION

11 If the executive-initiated actions of the 1990’s made anything clear, it is that, at a minimum,  
12 border construction does not deter or prevent immigration, but instead creates its own set of social,  
13 economic, humanitarian and environmental crises. The risk of harm to the nation is the unilaterally  
14 proposed “wall” itself. Defendants’ unconstitutional usurpation of the role of Congressional  
15 appropriations powers and inaccurate claims of utility would build only one thing: a monument  
16 dedicated to racial discrimination, violence, and harms to people of color, and accordingly it is  
17 against the public interest. This Court—aware of the myriad harms that will occur as a result—  
18 should decline to permit the Administration to turn its discriminatory motivations into a physical

1 barrier. For the reasons stated above, this Court should grant Plaintiffs' Motion for Preliminary  
2 Injunction.
