WHEREAS, on July 29, 2020, 2 Andy Enterprise Corporation d/b/a Cuon-Vietnamese Street
 Food ("Plaintiff") filed the instant action (the "Action") against Wells Fargo & Company and Wells
 Fargo Bank, N.A. (together, "Defendants");

WHEREAS, on September 1, 2020, the Action was found to be related to a prior action pending
in this District, *Marselian* v. *Wells Fargo & Company*, No. 4:20-cv-3166-HSG, and the Action was
accordingly reassigned to the Honorable Haywood S. Gilliam, Jr.;

WHEREAS, on September 2, 2020, following the reassignment of the Action to the Honorable
Haywood S. Gilliam, Jr., the Court set the Initial Case Management conference for October 27, 2020
(ECF No. 15);

WHEREAS, on October 9, 2020, Plaintiff and Defendants (the "Parties") filed a stipulated
request to continue the October 27, 2020 Initial Case Management conference to 30 days after the Court
issued a decision on Defendants' (then-anticipated) Motion to Compel Arbitration and Dismiss
("Motion") and to set a briefing schedule on that Motion (ECF No. 17);

WHEREAS, on October 13, 2020, the Court issued an Order granting the Parties' request to
continue the Initial Case Management conference to "30 days following the Court's order on the

WHEREAS, the Parties request that pursuant to the Court's October 13 Order (ECF No. 20), the
Initial Case Management Conference, currently set for December 10, 2020, be continued until 30 days
following the Court's order on the motion to compel arbitration.

NOW THEREFORE, it is hereby stipulated and agreed by the parties, subject to the order of the
Court, that the Initial Case Management Conference shall be continued until 30 days after the Court
issues a decision on Defendants' Motion.
