1 Pursuant to Local Rule 6-1 and 6-2, Plaintiff LinkedIn Corporation (“Plaintiff”) and  
2 Defendants Mantheos Pte. Ltd., Jeremiah Tang, Yuxi Chew, and Stan Kosyakov (collectively,  
3 “Defendants”), through their respective attorneys, stipulate and declare as follows:

4 WHEREAS, Plaintiff filed the Complaint on February 1, 2022 (ECF No. 1);

5 WHEREAS, Plaintiff served the Complaint on February 3, 2022 (ECF No. 12);

6 WHEREAS, on February 23, 2022, Plaintiff and Defendants stipulated to extend the

19 convenient.
