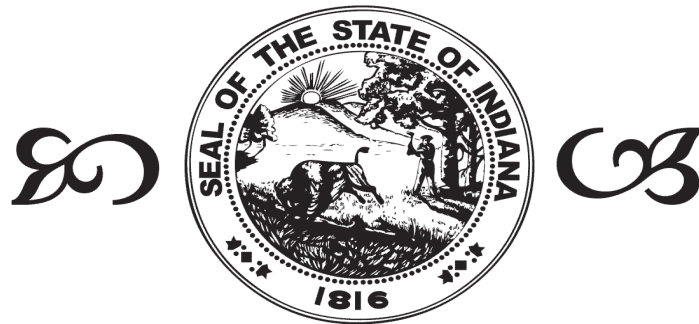
ORDER GRANTING APPLICATION
