The 20 parties may Stipulate to a briefing schedule subject to the Reply brief being filed on or before 21 January 4, 2009. 22 With respect to the parties' dispute regarding whether Defendant is obligated to comply with 23 Fed. R. Civ. P. 26(a), the Court finds that it does, even with its anticipated Motion to Dismiss.
