10 **WRIT OF HABEAS CORPUS AD TESTIFICANDUM**

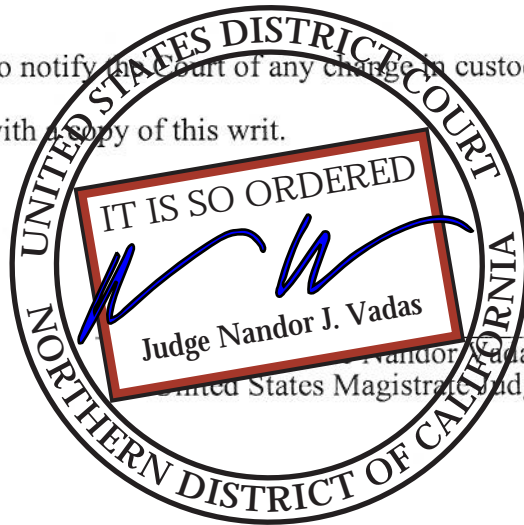
11 To: The Warden of the Correctional Training Facility,
