Pursuant to this Court's Order dated February 4, 2009, plaintiff JOHN GORMAN and defendant MBNA America Bank, N.A. ("MBNA") hereby submit the following Joint Case Management Conference Statement:

On January 12, 2009, the United States Court of Appeals for the Ninth Circuit issued its opinion affirming in part and reversing in part this Court's Order of June 23, 2006. *See Gorman v. Wolpoff & Abramson, LLP*, 552 F.3d 1008 (9th Cir. 2009).

Pursuant to Federal Rule of Appellate Procedure 41(b), absent an order shortening or extending the time, the Ninth Circuit's mandate "must issue 7 calendar days after the time to file a petition for rehearing expires, or 7 calendar days after entry of an order denying a timely petition for penal hearing, petition for rehearing en banc, or motion for stay of mandate, whichever is later." The Ninth Circuit did not issue an order shortening or extending the time for the issuance of the mandate.

On January 27, 2009, the Ninth Circuit issued an Order granting MBNA an extension of time until February 25, 2009 to file a Petition for Panel Rehearing and Rehearing En Banc. *See* Exhibit A, hereto.

On February 2, 2009, the Ninth Circuit issued an Order granting Gorman an extension of time until February 25, 2009 to file a Petition for Panel Rehearing and Rehearing En Banc. *See* Exhibit B, hereto.

On February 24, 2009, Gorman filed in the Ninth Circuit his Petition for Panel Rehearing.

On February 25, 2009, MBNA filed in the Ninth Circuit its Petition for Panel Rehearing and Rehearing En Banc.

Pursuant to Federal Rule of Appellate Procedure 41(d)(1), the "timely filing of a petition for panel rehearing [or] petition for rehearing en banc . . . stays the mandate until disposition of the petition . . . unless the court orders otherwise."

The Ninth Circuit has not yet ruled on the parties' Petitions for Panel Rehearing and Rehearing En Banc, nor has it issued its mandate.
