1           WHEREAS, on July 1, 2009, this Court entered an Order Staying Case Until Completion  
2 of Mediation that, *inter alia*, required plaintiffs to file their Motion for Class Certification on  
3 October 23, 2009; required defendants to file their oppositions to class certification on November  
4 20, 2009; required plaintiffs to file their reply in support of class certification on December 18,

17           3.       The hearing on plaintiffs' Motion for Class Certification shall be on  
18 **February 22, 2010 at 9 a.m.**


