4 noticed for January 18, 2011, and Plaintiffs filed their opposition on December 20, 2010;

5 WHEREAS, on January 17, 2011, Apple announced that Mr. Jobs was taking a medical  
6 leave;

7 WHEREAS, on January 18, 2011, in light of Mr. Jobs's medical leave, the parties agreed to  
8 take the motion off calendar, without prejudice;

9 WHEREAS, on January 18, 2011, the Court vacated the hearing; and

10 WHEREAS, Counsel for Plaintiffs asked Apple to agree to a new hearing date on a shortened  
11 schedule, and on March 3, 2011, Apple agreed to a hearing on March 15, 2011.

12 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and among the  
13 parties, subject to Court approval, the hearing on Apple's Motion for Protective Order Preventing the  
14 Deposition of Steve Jobs will be held on March 15, 2011.
