5	Professor Roger G. Noll, stating that he can show antitrust impact and a methodology for measuring
6	damages in accordance with the Court's May 19, 2011 Order;
7	2. July 15, 2011: Defendant shall file its Response to the Supplemental Declaration, if
8	any; and
9	3. July 15, 2011: Plaintiffs and Defendant shall submit a Stipulation setting forth the
10	dates for Professor Noll to complete a Supplemental Report that is consistent with the Court's
11	May 19, 2011 Order and for Defendant to submit its Supplemental Rebuttal Expert Report.
