3. 4 The Petition for Certification shall remain on calendar for hearing on November 5 22, 2010. Carlyle's Opposition to the Petition for Certification shall be due on October 22, 2010 6 and NVIDIA Defendants' Reply shall be due on November 5, 2010.

7 4. In the event mediation is unsuccessful, litigation and discovery in Carlyle's action 8 (Case No. 05-00427 JW) may resume. However, the NVIDIA Defendants do not hereby waive 9 the right to seek a stay of such proceedings pending resolution of the Petition for Certification and 10 Carlyle does not hereby waive the right to oppose such a request for a stay. Within 10 days after 11 mediation, the parties shall submit a joint statement reporting to the Court whether mediation was 12 successful or unsuccessful.

5. 13 The parties agree that the Case Management Conference currently scheduled for 14 July 19, 2010 at 10:00 a.m. should be taken off calendar pending mediation.
