STIPULATION

25 Subject to the approval of this Court, the parties hereby stipulate to the following
26 modification of the pretrial conference date set forth in this Court's August 22, 2008, Order.

1 WHEREAS, on August 22, 2008, this Court issued its Clerk’s Notice Of Continuance Of
2 Pretrial Conference on its own motion, setting forth the date for the pretrial conference in this
3 action to be held on October 9, 2008;

4 WHEREAS, NAVTEQ’s trial counsel has a trial scheduled for late September and early
5 October that likely conflicts with the October 9, 2008, pretrial conference;

6 WHEREAS, the parties have worked together to find the next earliest pretrial conference
7 date convenient for the parties and the Court’s schedule;

8 WHEREAS, the next earliest pretrial conference date convenient for the parties as well
9 as the Court’s calendar is October 16, 2008;

10 WHEREAS, NAVTEQ’s trial counsel expects that he will be available for a pretrial
11 conference on October 16, 2008, and will inform the Court and the parties in the event of any
12 unexpected trial delay that could impact this date.

13 Accordingly, IT IS HEREBY STIPULATED by and between Tele Atlas N.V., Tele
14 Atlas North America, and NAVTEQ Corporation, through their respective counsel of record, as
15 follows:

- 16 (1) The pretrial conference date set forth in this Court’s August 22, 2008, Order shall
17 be continued to October 16, 2008.
- 18 (2) Pretrial submissions will be due in accordance with the Court’s Standing Order
19 Re Pretrial Preparation: October 2, 2008, for initial submissions (10 court days
20 prior to pretrial conference) and October 9, 2008, for responsive submissions (5
21 court days prior to pretrial conference).
