1 The Court having reviewed the parties' stipulation to further modify the briefing and  
2 hearing schedule for Plaintiffs' motion to certify a California class and motion for leave to add a  
3 new class representative and the accompanying declaration of counsel, and having found good  
4 cause shown, IT IS ORDERED as follows:

5 The Court VACATES the current deadlines associated with Plaintiffs' motion to certify a  
6 California class and motion for leave to add a new class representative, which are: October 30,  
7 2009 for Plaintiffs' reply papers; and hearing on November 13, 2009. Further, the Court sets the  
8 following new schedule with respect to Plaintiffs' motions: Plaintiffs' reply papers are to be  
9 filed and served no later than November 30, 2009; and the hearing on Plaintiffs' motion to certify  
10 a California class and motion for leave to add a new class representative is set for January 8,  
11 2010.

12 Furthermore, with respect to Plaintiffs' reply to motion to certify a California class and  
13 motion for leave to add a new class representative, the page limit requirements contained in Civil  
14 Local Rule 7-3(c) shall be increased to 20 pages.
