4 A. As used herein, the terms “you” and “your” refer to Plaintiff Howard Stern and his  
5 agents, representatives, employees, subsidiaries, affiliates, attorneys, or others acting on his  
6 behalf.

7 B. As used herein, the connectives “and,” “or,” and “and/or” shall be construed either  
8 disjunctively or conjunctively as necessary to bring within the scope of the discovery requests all  
9 responses that might otherwise be construed to be outside of the scope.

10 C. As used herein, the words “person” and “persons” shall include natural persons,  
11 corporations, firms, partnerships, associations, joint adventures, trusts, and estates.

12 D. As used herein, the words “document” and “documents” are used in the broadest  
13 sense to include all forms of tangible expression, and include but are not limited to “writings and  
14 recordings” as defined under Rule 1001 of the Federal Rules of Evidence, and further includes,  
15 but is not limited to, each and every writing, letter, memorandum, offering document, telegram,  
16 handwritten note, periodical, pamphlet, report, evaluation, record, study, test result, working  
17 paper diary, chart, paper, graph, index, data sheet, data processing card, storage media, tape  
18 recording, electronic program and mail, or any other writing or electronically stored information  
19 however produced or reproduced.

20 E. As used herein, the words “all documents” means each and every document as  
21 above defined known to you and every such document that can be located or discovered by  
22 reasonable diligent efforts.

23 F. As used herein, the words “communication” and “communications” mean any  
24 meeting, conversation (face-to-face, telephonic, or otherwise), letter, discussion, telex message,  
25 cable, correspondence, message, tape-recorded message, electronic mail or message, voicemail  
26 message, or other occurrences in which thoughts, opinions, or information are transmitted  
27 between or among two or more persons or between or among one or more persons and any  
28

1 electronic, photographic, or mechanical device or devices for receiving, transmitting, or storing  
2 data or other information.

3 G. As used herein, the words “online advertising” mean any advertisement viewed  
4 and/or displayed via the internet.

5 H. As used herein, the words “offline advertising” mean any advertisement viewed  
6 and/or displayed in any medium other than the internet including, but not limited to, print, radio,  
7 television, billboard, mass transportation signage, etc.

8 I. As used herein, the word “Complaint” refers to the Second Amended Complaint in  
9 this action.

10 J. As used herein, the term “Agreement” refers to the contract you claim you entered  
11 into with Google to advertise on Google’s AdWords program, which the Court in this action has  
12 found to include the Google, Inc. AdWords Program Terms and Conditions, Frequently Asked  
13 Questions, and the terms of each advertising campaign submitted or modified by the Plaintiffs in  
14 this action.

15 K. As used herein, the words “your website” shall mean and refer to all websites  
16 located at or below the second-level domains <http://www.homeworksolvers.net>, and all other  
17 websites which are operated by you or on your behalf, including any website at which orders may  
18 be placed for any of your products.

19 L. As used herein, the words “the AdWords website” shall mean and refer to all  
20 websites located at or below the second-level domain <http://adwords.google.com>.

### 21 INSTRUCTIONS

22 A. If objection is made to part of an item or category, the part shall be specified.

23 B. You shall produce copies of responsive documents either as they are kept in the  
24 usual course of business or organized and labeled to correspond with the categories in the request.

25 C. Whenever you do not produce for inspection a document in response to a demand  
26 because of a claim of privilege or any other protection from disclosure, you shall nevertheless  
27 identify with particularity any such document by providing (i) a written list of each such  
28 document; (ii) the type of each such document (e.g., letter, memorandum, telegram, notes of

1 telephone conversation); (iii) the date each such document was written or generated; (iv) the  
2 author of each such document; (v) each person to whom each such document is directed,  
3 addressed, sent, delivered, mailed, given, or disclosed; (vi) the person who received a copy of  
4 each such document; (vii) the general subject matter of each such document (as fully as possible  
5 without destroying the asserted privilege or other protection from disclosure); and (viii) each
