3 hereto as "Exhibit A." The Notice of Supplemental Authority is based on an Opinion issued by the
4 United States Court of Appeals for the Seventh Circuit on November 27, 2006, affirming the district
5 court's order permanently enjoining enforcement of an Illinois statute criminalizing the sale or rental
6 of certain sexually explicit or "violent" video games to minors. *Entertainment Software Ass'n, et al.*
7 *v. Blagojevich*, ___ F. 3d ___, Nos. 06-1012, 06-1048 & 06-1161 (7th Cir., Nov. 27, 2006). This
