15	On May 11, 2009, the parties were scheduled to appear for a hearing in response to the
16	Court's March 26, 2009 Order to Show Cause Re: Contempt. (See Docket Item No. 172.)
17	Plaintiffs' counsel appeared for the hearing, however, neither Defendants' counsel nor Defendant
18	Piazza appeared. Instead, affiliated local counsel appeared to inform the Court that Defendants' lead
19	counsel missed his flight from Las Vegas, thus rendering him unable to attend the hearing.
20	Following the May 11 hearing, Defendants' counsel submitted a response to the Order to Show
21	Cause, contending that Defendant should not be held in contempt for his failure to attend a judgment
22	debtor examination on March 23, 2009. (See Docket Item No. 178.)
23	In light of the representations of Defendants' local counsel at the hearing, the Court
24	CONTINUES the hearing on the Court's Order to Show Cause to June 15, 2009 at 9 a.m., which
25	the Court will hold in conjunction with the previously scheduled hearing on the matter of
26	receivership. (See Docket Item No. 179.)
