7 and, if necessary, supplemental briefing by September 2, 2010; and

8 **WHEREAS**, pursuant to this Court’s Order, Plaintiffs must submit any responsive
9 briefing by September 8, 2010; and

10 **WHEREAS**, the parties agree that, due to Labor Day holiday and scheduling conflicts,
11 there is good cause to extend the time for the parties to submit the documents requested by this
12 Court’s Order; and

13 **THEREFORE, AND SUBJECT TO THE APPROVAL OF THIS COURT, IT IS**
14 **HEREWITH STIPULATED AND AGREED BY COUNSEL FOR THE PARTIES AS**
15 **FOLLOWS:**

16 1. Defendant’s revised privilege log and, if necessary, supplemental briefing,
17 currently due on September 2, 2010 shall be due on September 7, 2010;

18 2. Plaintiffs’ responsive brief, currently due on September 8, 2010, shall be due on
19 September 13, 2010.
