23 1. My name is Lee Buttle. I have personal direct knowledge of the matters herein
24 and if called as a witness, I could and would competently and truthfully testify as to each of the

26 2. I am a member and manager of plaintiff KinderStart.com LLC ("KinderStart"), a
27 California limited liability company. I manage and monitor the finances of KinderStart.

28 3. KinderStart does not have any paid employees or paid staff, and has no business
operations other than maintaining its website www.kinderstart.com.

4. In the calendar year of 2006, KinderStart derived 100% of its gross revenues
from advertising. In that year, cash remittances of revenues did not exceed \$8,000, and the
accrued revenues did not exceed \$5,000.00. During the calendar year of 2007 thus far, there has
been no material increase in KinderStart's revenues or profits.
