

This case is scheduled for a Pretrial Conference on April 25, 2011. Pursuant to the Federal Rules of Civil Procedure and Local Rules of this Court, the parties conferred and duly submitted a Joint Preliminary Pre-Trial Statement. (See Docket Item No. 275.) In the Joint Preliminary Pre-Trial Statement, both parties contend that the “matter is currently not ready for trial.” (Id. at 2-3.) The parties further contend that several Motions relating to the discovery phase, including Plaintiff’s Motion to Exclude Defendants’ Expert Designations and Defendants’ Motion to Strike Plaintiff’s Rebuttal Expert Designation, are pending. (Id. at 1.) In light of the parties’ contention that the matter is not currently ready for trial and the pending Motions, the Court finds that a Pretrial Conference is premature at this time.
