On August 23, 2006, on behalf of Io Group, Inc., I, filed in the United States 2 District Court for the Northern District of California a civil complaint against DATA 3 CONVERSIONS, INC., a South Carolina corporation d/b/a AEBN and pornotube.com. The 4 Clerk assigned the case to Magistrate Judge Howard R. Lloyd in the San Jose Division attaching 5 the docket number C-06-5162 (HRL). 6 7 4. On August 30, 2006, on behalf of Io Group, Inc., I filed in the United States 8 District Court for the Northern District of California a civil complaint against WEBNOVAS 9 TECHNOLOGIES, INC., a Canadian business entity type unknown, and GONETMARKET, 10 INC., a Nevada Corporation. The Clerk assigned the case to the Honorable Jeffery S. White in the 11 San Francisco Division attaching the docket number C-06-5334 (JSW). 12 13 5. The above-referenced cases are related in the following manner: a) The cases have 14 substantially the same parties in that the Plaintiff in all three cases is identical, namely Io Group, 15 Inc.; and b) The matters pertain to identical property rights, namely the catalog of films produced 16 and owned by plaintiff Io Group, Inc. 17 18 6. These three cases all deal with a similar and unique legal question, whether a 19 website that displays video content contributed by others without authorization from the copyright 20 owner can be held liable for copyright infringement. The websites at issue in each of the three 21 matters operate in a substantially similar manner. Because the three cases are likely to be 22 determined through resolution of this overriding legal question, hearing the cases before different 23 24 judges could produce conflicting results. 25 7. Moreover, if the cases are conducted before different judges there is likely to be an 26 unduly burdensome duplication of labor and expense. In addition to labor involved in resolving 27 the identical legal issues, much of the development of the factual record would also be duplicative. 28

1	Specifically, establishing ownership and registration of the infringed content and required expert				
2	testimony regarding technology would be duplicative in the three cases.				
3	8. Because the claims in the above-referenced cases involve similar parties, property				
5	rights and overlapping factual and legal issues of law, Plaintiff Io Group, Inc. contends that				
6	assignment of the three matters to Magistrate Judge Lloyd in the San Jose Division will likely				
7	conserve judicial resources and promote efficient determination of the actions.				
8	9. A stipulation could not be obtained regarding this Motion for Administrative Relief				
9	in compliance with Local Civil Rule 7-11(a) because: a) parties are not authorized to relate cases				
10 11	via stipulation and b) most defendants have yet to appear
