11 Pursuant to Fed. R. Civ. P. 41(a)(1)(A)(ii), the Parties hereby stipulate and agree to the
12 dismissal of all of Plaintiff Natalie Amaya's claims against Defendant Kyphon, Inc. in this matter.
13 The dismissal of these claims shall be with prejudice.

14 1. Ms Amaya is a Named Plaintiff in this putative class action.

15 2. Ms. Amaya has decided to dismiss all of her claims against Kyphon in this case
16 because she does not want to go through the rigors of litigation.

17 3. Ms. Amaya therefore requests that this Court dismiss all of her claims against
18 Kyphon in this action. *See* Affidavit of Natalie Amaya, attached hereto.

19 4. Ms. Amaya understands that this dismissal will be made with prejudice, meaning
20 that she will not have the opportunity to revive these claims. *Id.*

21 5. A class has not yet been certified in this case.

22 6. Moreover, each of the other six Plaintiffs is still willing to serve as Class
23 Representatives.

24 7. Accordingly, dismissal of Ms. Amaya's claims will not prejudice any members of
25 any class that is certified by the Court.

26 WHEREFORE, the Parties respectfully request that this Court enter an Order dismissing
27 all of Plaintiff Natalie Amaya's claims pending in this lawsuit with prejudice.
