5 This Writ has been issued at the request of the United States of America to enforce the  
6 collection of a civil judgment entered in favor of the United States against the defendant for a  
7 debt in the original amount of \$97,183.13. There is a balance due of approximately \$95,955.27  
8 which includes costs and interest computed through April 4, 2011.

9 The following are the steps that you must take to comply with this Writ. If you have any  
10 questions, you should consult with your attorney.

11 1. Pursuant to 28 U.S.C. § 3205(c)(2)(F), if you have in your custody, control, or  
12 possession any property of the defendant in which the defendant has a substantial nonexempt  
13 interest, or if you obtain custody, control, or possession of such property while this Writ is in  
14 effect, you must immediately withhold such property from the defendant and retain it in your  
15 possession until you receive instructions from the Court which will tell you what to do with the  
16 property.

17 2. Pursuant to 28 U.S.C. § 3205(c)(2)(E), you are required to answer this Writ within  
18 10 days after service of this Writ upon you. You must answer the Writ even if you do not have in  
19 your custody, control, or possession any property of the defendant. Pursuant to 28 U.S.C. §  
20 3205(c)(4), your answer must state, under oath, the following information:

- 21 a. Whether or not you have in your custody, control, or possession, any  
22 property owned by the defendant in which the defendant has a substantial  
23 nonexempt interest, including nonexempt disposable earnings;
- 24 b. a description of such property and the value of such property;
- 25 c. a description of any previous garnishments to which such property is  
26 subject and the extent to which any remaining property is not exempt; and
- 27 d. the amount of the debt you anticipate owing to the defendant in the future  
28 and whether the period for payment will be weekly or another specified  
period.

For your convenience, a form which addresses the above-requested information is attached and

1 may be used to answer the Writ.

2 3. After you complete the answer under oath, pursuant to 28 U.S.C. § 3205(c)(2)(E)  
3 and (c)(4), within ten (10) days after service of this Writ upon you, you must mail or deliver the  
4 original answer bearing the original signature of the person preparing the answer to the Court at

20 Please note that the attached form answer contains a certificate of service which needs to be  
21 completed by the person mailing the copies of the answer to the defendant and the attorney for  
22 the United States, and which needs to be filed with the Court along with the answer.

23 **IF YOU FAIL TO ANSWER THIS WRIT OR FAIL TO WITHHOLD PROPERTY**  
24 **IN ACCORDANCE WITH THIS WRIT, THE UNITED STATES MAY PETITION THE**  
25 **COURT FOR AN ORDER REQUIRING YOU TO APPEAR BEFORE THE COURT TO**  
26 **ANSWER THE WRIT AND TO WITHHOLD PROPERTY IN ACCORDANCE WITH**  
27 **THE WRIT BEFORE THE APPEARANCE DATE. IF YOU FAIL TO APPEAR OR DO**  
28 **APPEAR AND FAIL TO SHOW GOOD CAUSE WHY YOU FAILED TO COMPLY**  
**WITH THIS WRIT, THE COURT WILL ENTER A JUDGMENT AGAINST YOU FOR**  
**THE VALUE OF THE DEFENDANT'S NONEXEMPT INTEREST IN SUCH**  
**PROPERTY (INCLUDING NONEXEMPT DISPOSABLE EARNINGS). THE COURT**  
**MAY ALSO AWARD A REASONABLE ATTORNEY'S FEE TO THE UNITED STATES**

1 **AND AGAINST YOU IF THE WRIT IS NOT ANSWERED WITHIN THE TIME**  
2 **SPECIFIED HEREIN AND IF THE UNITED STATES FILES A PETITION**  
3 **REQUIRING YOU TO APPEAR.**
