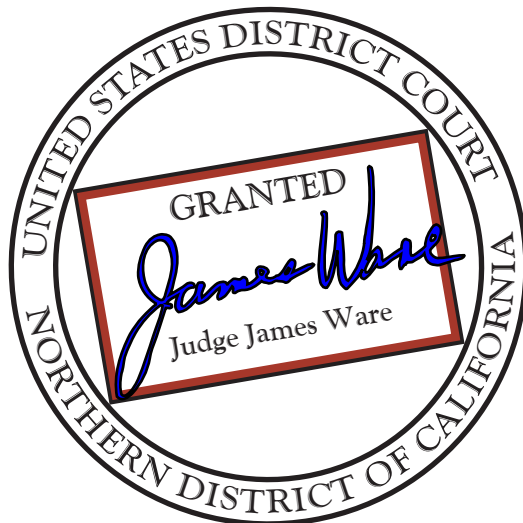



7 20, 2006.


