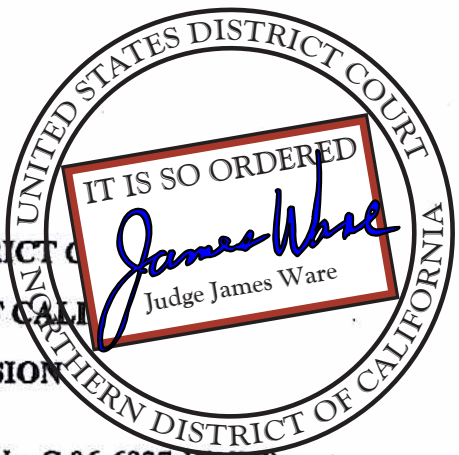

[Proposed] ORDER**


