	1 Notice and Request for Continuance	

Counsel for the parties filed a stipulation on December 3, 2008, notifying this Court of the
 settlement of this action, and requesting that the hearing set for December 5, 2008 on cross-motions
 for summary judgment be vacated.

On December 4, 2008, this Court entered its Order vacating the hearing date, and ordering
the parties to appear for a Case Management Conference on December 19, 2008, if a dismissal is not
on file with the Court by December 15, 2008.

7 The parties will not be able to file a dismissal by December 15, 2008 for the reason that Bob
8 Lewis Volkswagen is in Chapter 11 bankruptcy, Northern District of California Bankruptcy Case
9 No. 08-50015. Approval from the Bankruptcy Court will need to be obtained for the settlement.

Counsel for Bob Lewis Volkswagen is informed and believes that the Bankruptcy Court
approval process will take a minimum of 20 days from the date that required notices are filed in the
Bankruptcy Court, and will take a minimum of 35 days if objections to the settlement are lodged in
Bankruptcy Court. Counsel for Bob Lewis Volkswagen anticipates that bankruptcy counsel for Bob
Lewis Volkswagen will have the appropriate notices on file in the Bankruptcy Court by December
19, 2008.

The parties therefore respectfully request that this Court continue the Case Management
Conference currently set for December 19, 2008, until a date in February, 2009, to allow sufficient
time for Bankruptcy Court approval to be obtained, and then to file a stipulation for dismissal in this
action.
