1 I, Theresa A. Sutton, declare as follows:

2 1. I am an associate with the law firm of Orrick, Herrington & Sutcliffe LLP, counsel
3 to Plaintiffs Facebook, Inc. and Mark Zuckerberg. I am licensed to practice law in the State of
4 California. I have personal knowledge of the facts and circumstances set forth in this Declaration.
5 If called as a witness, I could and would testify competently to the matters set forth herein. I
6 make this Declaration pursuant to Civil L.R. 79-5(d).

7 2. On July 6, 2007, Defendants Pacific Northwest Software and Winston Williams
8 lodged exhibits with the Court pending this Court's ruling on Defendants' Administrative
9 Request to Seal those documents. Exhibit D to the Declaration of Scott Mosko in Support of
10 Defendants' Reply Memorandum contains private, confidential financial information.

11 3. Good cause exists for sealing Exhibit D. Exhibit D is Facebook's responses to
12 interrogatories served in Massachusetts in the now-dismissed action titled *ConnectU LLC v.*
13 *Mark Zuckerberg, et al* (Case No. 1:04-CV-11923 DPW). Exhibit D contains references to
14 specific amounts of money invested in Facebook by third parties. It also contains references to
15 specific grants of stock to employees and third parties. This information is private vis-à-vis the
16 investors and other stockholders, and it is not Plaintiffs' right to authorize disclosure of such
17 information. Exhibit D was designated as "Confidential — Attorneys' Eyes Only" under the
18 Protective Order entered in the Massachusetts action.

19 4. Defendants also lodged as sealable Exhibit B to the Mosko Declaration. Exhibit B
20 is Facebook's Bylaws. Though it is not generally available to the public and has not been filed
21 publicly, Facebook agreed (prior to its filing with the Mosko Declaration) to de-designate that
22 document. Exhibit B need not be placed under seal.
