I am licensed to practice law in the State of 4 California. I have personal knowledge of the facts and circumstances set forth in this Declaration. 5 If called as a witness, I could and would testify competently to the matters set forth herein. I 6 make this Declaration pursuant to Civil L.R. 79-5(d). 7 2. On September 19, 2007, Defendants Cameron Winklevoss, Tyler Winklevoss, and 8 Divya Narendra lodged exhibits with the Court pending this Court's ruling on Defendants' 9 Administrative Request to Seal those documents (Dkt. No. 162). These are the same exhibits that 10 Defendants lodged with the Court pending this Court's ruling on Defendants' Administrative 11 Request to Seal these exhibits attached to Scott Mosko's Declaration in Support of Defendants 12 Cameron Winklevoss, Tyler Winklevoss, and Divya Narendra's Motion to Dismiss (Dkt. No. 13 138). Good cause exists for sealing Exhibits V-8-E, V-8-G, V-8-H, and V-4 to the Declaration of Scott Mosko in Support of Defendants' Memorandum. 14 15 3. On September 28, 2007, this Court granted the Joint Order Re Sealing Motions 16 ordering Exhibits V-8-E, V-8-G, V-8-H, and V-4 to the Declaration of Scott Mosko in Support of 17 Defendants' Memorandum be filed under seal for good cause shown (Dkt. No. 174). 18 4. Exhibit V-8-E is a document related to the registration of the Facebook.com 19 domain registration. The document contains Mark Zuckerberg's parents' home address and 20 phone number. Because of the substantial public attention this case has drawn, Mr. Zuckerberg is 21 concerned that the release of his family's home address and phone number will invite third parties 22 to contact his family, imposing an unnecessary and avoidable burden on them. 23 5. Exhibit V-8-G is a copy of an Agreement between Facebook and a third party, Equinix. The Agreement was marked confidential by the third party. It is not Facebook's 24 25 information to make publicly available. 26 6. Exhibit V-8-H is a copy of excerpts from the deposition of Mark Zuckerberg. The 27 testimony includes confidential and commercially sensitive financial information (in the form of a 28 valuation placed on the company) related to Facebook, Inc.

1	7. Defendants also lodged Exhibit V-4 . This document, Facebook's Opposition to					
2	Defendants' Motion to Quash, contains information ConnectU designated as Confidential and					
3	was filed under seal by the Superior Court of California before this action was removed to this					
4	Court.					
5	8. Defendants also lodged as sealable Exhibits V-5-Q and V-8-B . Facebook					
6	previously withdrew its "Confidential" designation on these documents on September 7, 2007					
7	(Dkt. No. 147). Exhibits V-5-Q and V-8-B need not be placed under seal.
