I, Theresa A. Sutton, declare as follows:

1. I am an attorney with the law firm of Orrick, Herrington & Sutcliffe LLP, counsel for Plaintiffs FaceBook, Inc. and Mark Zuckerberg in the above-captioned action. I am a member of the Bar of the State of California. I make this Declaration in support of Plaintiffs' Civil L.R. 7-11 Miscellaneous Administrative Request for Order Setting Case Management Conference. I have personal knowledge of the facts set forth in this declaration and could and would competently testify thereto under oath if called as a witness.

1. On Thursday, December 6, 2007, I sent an email to Valerie Wagner, counsel for David Gucwa, and Scott Mosko, counsel for the remaining defendants, asking if the defendants would stipulate to setting a Case Management Conference on Friday, December 14, 2007.
