1 **WITHDRAWAL OF MOTION TO WITHDRAW AS COUNSEL**
2 **FOR DEFENDANT WINSTON WILLIAMS**

3 Pursuant to Civil L.R. 7-7(e), Finnegan Henderson ("The Firm") hereby withdraws its
4 Motion to Withdraw as Counsel for Winston Williams, currently scheduled for hearing on January
5 23, 2008. On December 29, 2007, The Firm received its first communication from Mr. Williams
6 since early November 2007. On December 31, 2007, Mr. Williams left a voicemail with The Firm
7 providing a temporary Florida-based telephone number as his new contact. Thereafter Mr. Williams
8 was advised of this Court's Order compelling further responses to discovery and later was
9 provided previously-produced documents to assist in his investigation consistent with this Court's
10 December 12, Order. Pursuant to that Order, late in the afternoon of January 2, 2008, Mr. Williams
11 signed a declaration that was later served on Plaintiffs. The Firm again lost touch with Mr. Williams
12 until January 7, 2008, when at approximately noon that day, he confirmed his willingness and ability
13 to communicate with The Firm as it concerns this action.
