2 motion asking the Court to file under seal Plaintiffs' Administrative Request Pursuant to Civil
3 L.R. 7-11; Declaration of I. Neel Chatterjee in Support Thereof; and Proposed Order Granting
4 Administrative Request Pursuant To Civil L.R. 7-11.

5 The parties entered into, and the California Superior Court issued, a Stipulated Protective
6 Order on January 23, 2006, which prohibits either party from filing in the public record any
7 documents that have been designated as "Confidential" or "Highly Confidential" pursuant to the
8 Protective Order.

9 Plaintiffs' Administrative Request, and all documents filed in support thereof, contain
10 confidential information that is subject to the protection in the protective order. In light of the
11 high profile nature of this case, and the parties' desire to keep the details of this Administrative
12 Request private, Plaintiffs request that their Administrative Request and its supporting papers
